

EXECUTIVE SUMMARY OF BID EVALUATION REPORT

Project Title: Coastal Protection, Landscaping and Infrastructural Works at Providence Site on the East Coast of Mauritius

Reference number of procurement: CPB/06/2020

1. Scope of Contract:

The works consist of:

- (i) About 10m wide fill on average between the seaward edge of the existing coast road and the landward edge of the rock revetment;
- (ii) Rock revetment comprising an armour layer and an under-layer over a total length of about 1175 m;
- (iii) Precast mass concrete kerb and fibre reinforced concrete wall alongside the revetment crest;
- (iv) About 1075 m of a 2-m wide walkway with pervious concrete surfacing alongside the rock revetment;
- (v) A 2.5m wide cycling track over a total length of about 975 m and associated traffic signage;
- (vi) Four access staircases to the sea;
- (vii) Perched coral-sand beaches at three locations;
- (viii) Parallel off-road parking facilities and bus lay-bys at four locations;
- (ix) Extension of some 15 no. existing culverts;
- (x) Masonry retaining walls;
- (xi) Pedestrian access with precast paving blocks finish at the Public Beach;
- (xii) Hardstand in reinforced and mass concrete, stairway and ancillary works;
- (xiii) Boat Ramp in reinforced and mass concrete, access road and ancillary works;
- (xiv) Timber hand railing and barrier; and
- (xv) Landscaping works comprising grassing and planting of selected tree species.

2. Procurement method used: Open National Bidding Method.

3. Date of Invitation of Bids: 03 July 2020.

4. Closing date for submission of bids: 21 August 2020.

5. Date and place of opening of bids: 21 August 2020 at the Central Procurement Board (CPB), Social Security House, Julius Nyerere Avenue, Rose Hill, Mauritius.

6. Number of bids received by closing date: Five.
