Executive Summary of Bid Evaluation Report

Operation and Management of Poudre D'or Trasnfer Station and Transportation of Wastes from Poudre D'or Transfer Station to Mare Chicose Landfill

1. Scope of Contract

The project comprises the following:-

- (i) Operation and maintenance of the Transfer Station at Poudre D'Or in a smooth running condition for the whole duration of the Contract and provision to be made for all necessary spare parts for the proper running of the station with competent and qualified personnel;
- (ii) Transport all daily incoming wastes, whatever be the peak, (approximately 250-300 Tonnes) from the Transfer Station to Mare Chicose Landfill.

The station is expected to receive 180- 200 Tonnes of wastes per day from the catchment area, reaching up to a peak of 250 - 300 Tonnes during start of year, end of year and festive periods.

- (ii) Sorting of used tyres, paper and plastics from co-mingled wastes and their recycling.
 - The operator may choose to recycle the waste himself or deal with recyclers who are registered as per the Local Government (Registration of Recycler and Exporter) Regulations 2013 for the collection and carting away by the recyclers to their recycling facilities.
 - > The operator shall be responsible for securing markets and prices for the recyclables (paper, plastics and used tyres).
 - The operator may choose to invest on wastes sorting methodologies at his own cost to increase recovery rate of the recyclables (paper, plastics and used tyres).
 - > The operator shall have a proper system of record keeping of the recyclables (paper, plastics and used tyres) and submit monthly report to the Ministry.
 - > The operator shall comply with the provisions of relevant health and safety legislations.

- 4. Closing date for submission of bids: 20 June 2017
