

Executive Summary of Bid Evaluation Report

1. Scope of contract:

- 1.1 The services consist of Cleaning of beaches for Lot 1 and Lot 4 from bidders registered as Scavenging Contractors under the Local Government (Registration of Scavenging Contractors) Regulations 2004 at the following beaches, namely:

- Lot 1: Rs 42,784,582 incl VAT
- Lot 4: Rs 29,972,838 incl VAT

5	Brillant Cleaning Services Ltd	No	Bidder is not registered as Scavenging Contractor with the Ministry of Local Government. Furthermore, Bidder has not submitted its Technical Proposal and authorization of signatory/Power of Attorney.

7	Securiclean (Mtius) Ltd (under Administration)	No	The Bidder has not provided a Bank Certificate as stipulated at ITB 5.5(e) of the Bidding Document. The submissions in the Bidding Document have been signed by the Administrator whilst the delegation of power by resolution of Board, dated 17 September 2013, was given to Mr Jean Patrick Maurel. BEC found this to be contradictory to ITB 5.3(b). Furthermore, the Bidder Securiclean (Mtius) Ltd has submitted its financial statements for Year 2013 and Year 2014 only but none of the two financial statements submitted bear the seal of the Registrar of Companies.
8	Norba Nettoyage Ltee		The Bidder Norba Nettoyage Ltee has submitted a written confirmation (minutes

	No	<p>of Director's meeting) on delegation of power to sign the Bidding Document, but the BEC has found that this document is an authorization given for a different procurement exercise namely "Services for Street cleaning, Refuse Collection and Disposal including Carting Away of Post Cyclonic Wastes- Year 2016-2019 (Procurement Ref: OWB/CCPL/08/2015)".</p> <p>Based on the above, the BEC considers that this is a minimum qualifying criterion which the Bidder has failed to comply with, in accordance with ITB 5.3 (b) and PPO Directive No 3 issued pursuant to Section 7(b) of the Public Procurement Act "Guideline for determination of responsiveness of bid at Paragraph (IV) and sub-paragraph (k)" and subsequently amended by Directive 16 of 2014, which is a justifiable ground for rejection of the bid.</p>
