

Executive Summary of Bid Evaluation Report

Carting Away of Post Cyclonic Wastes from Temporary Dump Sites

Contract No. and Title: ENV/SWM/10/2015-2016

1. Scope of contract:

Proposals were invited from bidders for the Carting Away of Post Cyclonic Wastes from temporary Dump Sites.

Stage 1 consisted of managing the dump sites while Stage 2 comprised carting away of post cyclonic green wastes and other mixed wastes from temporary dumpsites to Mare Chicose landfill site or La Chaumiere Compost plant.

2. Procurement method used: Open National Bidding method

3. Date of invitation of bids: 23 November 2015.

4. Closing date for submission of bids: 28 December 2015 up to noon at latest.

5. Date and place of opening of bids: 28 December 2015 at 13 30 hours in the Conference Room of the Ministry of Environment, Sustainable Development, Disaster and Beach Management (Solid Waste Management Division), 10th Floor Emmanuel Anquetil Building, Port Louis.

6. Number of bids received by closing date: 3

7. Responsiveness of bids:

All three bids were found responsive for the lots quoted as follows:

9. Recommendation for Award:

- a) Lot 1 to Maxiclean Co ltd for the Carting Away of Post Cyclonic Wastes from temporary dump sites as follows:
 - 1) Option I – Rs 7,880,500, including VAT
 - 2) Option II – Rs 9,674,500, including VAT

- b) Lot 2 to Sotravic Ltee for the Carting Away of Post Cyclonic Wastes from temporary dump sites for the price of Rs 6,749,750, including VAT.

- c) Negotiations to be conducted with the bidder Sotravic Ltee for the Carting Away of Post Cyclonic Wastes from Temporary Dumpsites for Lot 3 to bring the bid prices of Option I and Option II within the allowable 15% of the cost estimate.
