

Executive Summary of Bid Evaluation Report

Project Title: Coastal Protection, Landscaping and Infrastructural Works at Bois des Amourettes Site

Reference Number of Procurement: ENV/ONB/12/2021

1. Scope of Works

The works comprise:

- about 10m wide filling between the edge of the existing Coast Road carriageway up to the landward edge of the rock revetment crest, including 4m for future road upgrading;
- about 450m long rock revetment bordering the fill along the entire waterfront of the site;
- L-shaped fibre reinforced concrete wall and precast concrete block alongside the crest of the revetment;
- two-metre wide walkway;
- 2 nos. pedestrian staircases to sea;
- minimum 4m wide strip for grassing and planting of selected trees;
- 1 no. bus bay;
- parallel off-road parking facilities at one location;
- hard scaping comprising retaining walls and a staircase at the NE end of the site;
- storm water drainage and culverts extension;
- timber handrailing and barrier;
- provision of 2 Nos. informative panels; and
- provision of concrete bases of lighting poles.
