

Executive Summary of Bid Evaluation Report

1.0 Scope of contract:

The scope of services comprises the following:-

1. Daily Cleaning of beaches;
2. Daily carting away of wastes;
3. Mowing and cutting of grassed areas;
4. Lopping and Pruning of branches;
5. Cutting and removal of stumps;
6. Felling of dry trees/trees representing danger;
7. Levelling of holes and furrows;
8. Maintenance of litter bins, lighting systems and amenities;
9. Burial of corals, leaves and seaweeds;
10. Spreading of seaweeds over flexible revetment wherever applicable;
11. Collection and Carting of Post Cyclonic wastes following instructions from the Client;
12. Refuse Collection;
13. Cleaning and Maintenance of toilet blocks; and
14. Provision of Watchmanship services.

2.0 Procurement method used: Open National Bidding method.

3.0 Date of invitation of bids: Bidders were invited on **13 December 2016** to submit bids for *Beach Cleaning, Refuse Collection and Maintenance of Toilet Blocks and Provision of Security on Main Beaches for Lot 4.*
