Government Notice No. 82 of 2025

THE WASTE MANAGEMENT AND RESOURCE RECOVERY ACT 2023

Regulations made by the under section 50 of the Waste Management and Resource Recovery Act 2023

- **1.** These regulations may be cited as the Waste Management and Resource Recovery (Registration of Scavenging Contractor) Regulations 2025.
- 2. In these regulations
 - "Act" means Waste Management and Resource Recovery Act 2023;
 - "facility" means a place where the scavenging contractor –
 - (a) keeps his vehicles which are used for the purpose of transporting wastes; and
 - (b) transits wastes that are collected prior to depositing them at the waste management facility.
- **3.** These regulations shall apply to the collection and transportation of solid waste.
- **4.** No person shall operate as a scavenging contractor unless he is registered as a scavenging contractor.
- **5.** (1) Any person who intends to operate as a scavenging contractor shall make an application to the Minister in the form set out in the First Schedule.
- (2) On receipt of an application made under paragraph (1), the Minister may –

- (a) cause an inspection of the vehicles which the applicant intends to use for the purpose of collecting and transporting wastes;
- (b) cause an inspection of such place as the applicant intends to use as a facility; and
- (c) require the applicant to provide such additional information as he deems necessary.
- **6.** (1) The Minister may approve or refuse an application made under regulation 5(1).
- (2) Where the Minister approves an application, he shall, on payment of the fee specified in the Second Schedule, issue a certificate of registration in the form set out in the Third Schedule.
- (3) Where the Minister refuses the application, he shall, not later than 21 days of his decision, inform the applicant accordingly.
 - (4) The certificate of registration issued under paragraph (2)
 - (a) shall be subject to such terms and conditions as the Minister may determine; and
 - (b) shall not be transferrable.
- (5) (a) A certificate of registration issued under these regulations shall be valid for a period of 3 years and may be renewed for further periods of 3 years.
- (b) An application for the renewal of a certificate of registration shall be made at least one month before the expiry of the certificate of registration.
 - (c) The application under subparagraph (b) shall be
 - (i) made in the form set out in the First Schedule; and

- (ii) accompanied by such fee as may be specified in the Second Schedule.
- (d) Any person who makes an application for the renewal of his certificate of registration after the expiry of the delay shall, together with the application fee, be liable to a surcharge of 35 per cent.
- (6) (a) Where a certificate of registration has been lost, destroyed, or defaced, the registered scavenging contractor shall make an application to the Minister for the issue of a duplicate certificate of registration.
- (b) The supervising officer shall, on being satisfied that the certificate of registration has been lost, destroyed or defaced, issue a duplicate certificate of registration.
- (c) Where a scavenging contractor finds the original certificate of registration after a duplicate thereof is issued to him, he shall forthwith surrender the original certificate of registration to the Minister

7. (1) Where a scavenging contractor –

- (a) has furnished false information at the time of his application for registration;
- (b) has furnished false information subsequent to the application for registration;
- (c) no longer satisfies the conditions for registration;
- (d) has been convicted of an offence under the Act or these regulations;
- (e) has breached or not complied with any terms and conditions of the certificate of registration;
- (f) has ceased to operate as a scavenging contractor; or

(g) operates his business in such a manner as may affect the health of, or be a source of nuisance to, the public,

the Minister may, cancel the registration.

- (2) Before cancelling the registration, the scavenging contractor shall be served a notice by registered post, requiring him to show cause, within 21 days from the date of the notice, why his registration should not be cancelled.
- (3) The Minister may, on being satisfied that it is expedient and in the public interest to do so, cancel the registration of a scavenging contractor.
- **8.** Every scavenging contractor shall display a copy of his certificate of registration in a conspicuous place at his office.
- **9.** Every scavenging contractor shall forthwith notify the supervising officer, in writing, of any change in address of the facility.
- **10.** The Department shall keep and maintain a register of scavenging contractors, in which shall be entered
 - (a) the name, address and contact details of every scavenging contractor; and
 - (b) such other particulars as the Minister may determine.
- 11. (1) The supervising officer may, without prior notice, make arrangements for on-site inspections of the vehicles used for the collection and transportation of solid wastes.
- (2) Every scavenging contractor shall allow access or cause access to be provided for the purpose of paragraph (1).

- **12.** (1) No public body shall enter into a contract for the collection and transportation of solid wastes with a scavenging contractor unless that scavenging contractor is registered under these regulations.
- (2) Every public body shall, for the purpose of procuring the services of a scavenging contractor, require every registered scavenging contractor who bids accordingly to submit a copy of his certificate of registration.
- **13.** Any person who contravenes these regulations shall commit an offence and shall, on conviction, be liable to a fine not exceeding 25,000 rupees.
- **14.** A certificate of registration issued under the Local Government (Registration of Scavenging Contractors) Regulations 2004 which is valid and in force on the coming into operation of these regulations, shall
 - (a) be deemed to have been issued under these regulations; and
 - (b) remain valid for a period of 60 days from the date of coming into operation of these regulations.
- **15.** These regulations shall come into operation on 1 October 2025.
