### Waste Carrier Licence

- A waste carrier licence is required to transport waste exceeding 500 kg in a vehicle.
- Downloadable Application Form
- Documents to be submitted with the Application Form
  - 1. Horsepower (original + one copy)
  - 2. One copy of Fitness Certificate
  - 3. A or B carriers licence (original + one copy)
- The Application form duly filled in should be submitted to:

- An appointment for examination of the vehicle will be given upon submission of the duly filled application form.
- Vehicles are examined at La Chaumière Transfer Station on Mondays and at La Laura Transfer station on Thursdays.
- If vehicle is found suitable to operate as a waste carrier, the applicant will be informed by phone to collect the voucher for payment of the licence fee at The Treasury, Mère Barthelemy Street, Port Louis.
- In case the vehicle is found to be unfit, the applicant would be informed on site of the necessary improvements to be made to the vehicle.
- After payment of the licence fee, the receipt has to be produced to obtain the Waste Carriers Licence.

#### **IMPORTANT NOTE:**

- No waste carrier licence would be issued to any person who has been convicted of an offence under the Local Government (Dumping and Waste Carriers) Regulations 2003, Local Government (Dumping and Waste Carriers) Regulations 2021 and the Environment Protection Act during the last 12 months preceding his application.
- No waste carrier licence would be issued to a vehicle that is licenced to transport food (Food Transport vehicle)


Waste carrier with a tipping device (Tipper Lorry)














