

**LIST OF CONDITIONS- PROPOSED CONSTRUCTION AND
OPERATION OF A CEMENT BLENDING PLANT AT FORT GEORGE
BY LAFARGE (MAURITIUS) CEMENT CO. LTD [ENV/1515]**

1. All other necessary permits/clearances from the relevant authorities, including clearance from the Ministry of Industry, Commerce and Consumer Protection (Commerce and Consumer Protection Division) as well as clearance from the Mauritius Ports Authority, shall be obtained and all the conditions attached therewith shall be scrupulously observed. A copy of all the permits/ clearances obtained shall be submitted to the Director of Environment.
2. The development shall be undertaken as per the mitigating measures stated in the EIA report and the additional information submitted unless as otherwise advised herein.
3. In accordance with section 18 2(/) of the Environment Protection Act 2002, the proponent shall submit to the Director of Environment, an Environmental Monitoring Plan (EMP) for approval prior to start of works. The proponent shall thereafter submit reports on the implementation, accordingly.
4. The Department of Environment shall be informed in writing of the date of completion of all works on site, with copy of the as-built layout plan for monitoring purposes and to ensure compliance with the conditions of the EIA licence as well as the proposals in the EIA report.
5. The standard of the blended cement shall meet the requirements as specified by the Mauritius Standards Bureau prior to putting the new product on sale on the local market.
6. Arrangement shall be made to inform consumers of the limited nature/scope of works for which the blended cement can be used by displaying conspicuously the relevant information on the bags of cement.

7. Necessary measures shall be taken during the construction/operation phase so as not to cause any nuisance by way of noise, odour, vibration and dust pollution to the neighbours and the surrounding environment.
8. Electric motors such as air compressors, pumps and other noise generating equipment shall be housed in soundproof enclosures so that the noise emanating therefrom be within permissible levels as per the Environment Protection (Environment Standards for Noise) Regulations 1997 promulgated under the Environment Protection Act.
9. The operation of the blending plant including the transportation of basaltic fillers and delivery of products shall not give rise to any dust nuisance.
10. The proponent shall ensure that the axle loads of the trucks entering and leaving the plant compound are in conformity with Road Traffic regulations and shall not exceed 10 tons per axle.
11. Appropriate measures shall be taken to avoid damage to public roads due to spillage of materials by heavy vehicles on the road surface.
12. The proponent shall make provision of an appropriate means to discharge storm water through mud/slits traps and hydrocarbon separators prior to open discharging to the receiving environment.
13. All domestic wastewater shall be disposed of via the existing septic tanks and absorption pits.
14. Solid wastes shall be regularly collected and disposed of as per the recommendations of the Local Authority.
15. The proponent shall adopt energy-saving devices such as economic bulbs, eco-friendly practices and other similar facilities.
16. Any proposed deviation shall be subject to an application to the Director of Environment. No deviation or part thereof shall be executed prior to the determination of the application by the Director.
