

LIST OF CONDITIONS – PROPOSED SETTING UP OF A  
DESALINATION PLANT FOR THE ECO ROD BUNGALOW PROJECT AT  
ST FRANÇOIS, RODRIGUES BY DR J.P. DE CHANTILLY  
(ENV/12/1467)

1. All other necessary permits/clearances from the relevant authorities shall be obtained and all the conditions attached therewith shall be scrupulously observed. A copy of all the permits/clearances obtained shall be submitted to the Director of Environment and Environment Division of the Commission for Rodrigues responsible for Environment.
2. The development shall be undertaken as per the mitigating measures stated in the EIA report and the additional information submitted, unless as otherwise advised herein.
3. The Department of Environment and the Environment Division of the Commission responsible for Environment in Rodrigues shall be informed in writing of the date of commencement of works for monitoring purposes. A detailed programme of work shall accordingly be submitted prior to the start of works.
4. In accordance with section 18(2)(f) of the Environment Protection Act 2002, the proponent shall submit to the Director of Environment, with copy to the Environment Division of the Commission responsible for Environment in Rodrigues, an Environmental Monitoring Plan for approval prior to start of works. The proponent shall thereafter submit reports on the implementation, accordingly.
5. The Department of Environment and the Environment Division of the Commission responsible for Environment in Rodrigues shall be informed in writing of the date of completion of all works on site, with copy of the as-built layout plan, prior to the start of operation for monitoring purposes and to ensure compliance with the conditions of the EIA licence as well as the proposals in the EIA report and the additional information submitted.

6. The proponent shall carry out monitoring of the water quality and the marine ecosystem of the lagoon every three months and submit results to the Environment Division of the Commission responsible for Environment in Rodrigues.
7. The promoter shall effect daily analysis of water samples at the dilution tank prior to its release into the rejection well and submit results on a monthly basis to the Environment Division of the Commission responsible for Environment in Rodrigues.
8. A Contingency Plan shall be set up to combat any case of accidental spillage of brine and chemicals. The contingency plan as provided for, under Section 30(3)(a) of the Environment Protection Act shall be submitted to the Environment Division of the Commission responsible for Environment in Rodrigues and the Director of Environment prior to operation.
9. The quality of the desalinated water after treatment shall comply with the Environment Protection (Drinking Water Standards) Regulations 1996 promulgated under the Environment Protection Act.
10. The backwash water shall be pre-treated so as to comply with the Environment Protection (Standards for Effluent Discharge) Regulations 2003 promulgated under the Environment Protection Act.
11. Public access to the sea and the beach shall be clear of any encumbrance and the public shall have free and unrestricted access thereto
12. No waste (liquid or solid) treated or untreated shall be disposed of at any watercourse/ sea.

13. Electric motors such as generators and other noise generating equipment shall be housed in soundproof structures so that the noise emanating therefrom be within permissible levels as per the Environment Protection (Environment Standards for Noise) Regulations 1997 promulgated under the Environment Protection Act.
14. The proponent shall not cause any form of nuisance by way of noise, odour or dust pollution to the neighbours and to the public in general.
15. If during the implementation of the project, any environment problem or negative impact ensues, the proponent shall accordingly inform the Ministry of Environment and the Environment Division of the Commission responsible for Environment in Rodrigues immediately and shall redress the harm caused to the complete satisfaction of the Ministry of Environment and the Environment Division of the Commission responsible for Environment in Rodrigues.
16. Any proposed deviation shall be subject to an application to the Director of Environment. No deviation or part thereof shall be executed prior to the determination of the application by the Director.
